Dear Mindbenders,






From the Editor's Desk

MINDBENDERS 1998 REUNION "WEST COAST ADVENTURE" 1-5 JULY 1998

Arrangements are being finalized for our next reunion in sunny Southern California. As this is our first West Coast reunion, we're looking forward to seeing our West Coast members who have been unable to attend previous reunions in the East or Mid-West. This is also a golden opportunity for you Easterners to come out for the reunion and then continue your vacation and visit

many of the lovely and unusual attractions for which California is noted. As an additional day has been added to our schedule to provide more opportunity to visit local sights, check-in starts on Wednesday, 1 July 1998, culminating with our traditional banquet Saturday evening, 4 July 1998.

Although Linda and I live near Disneyland in Anaheim, California, our review of many of the hotels in the area led to the selection of the Buena Park Hotel and Convention Center in Buena Park, California for the reunion site. The Buena Park Hotel, 7675 Crescent Avenue, Buena Park, CA, is located on Buena Park's Entertainment Corridor approximately five miles Northwest of Disneyland and just a short complimentary shuttle ride to/from Disneyland Park. The hotel is adjacent to Knotts Berry Farm amusement park and within walking distance of the Movieland Wax Museum, Wild Bill's Western Dinner Show, Medieval Times Dinner Show, and Ripley's Believe It Or Not. It is also only four blocks from the Buena Park Mall with its 160 stores and 8 cinemas. For what the hotel provides, we believe their special group rate (\$69 + tax per night for up to 4 people) is more affordable than similar hotels near Disneyland which are around \$100 or more per night. Of course, cheaper accommodations may be available at smaller motels (this is the height of the tourist season), but the rooms are not as nice and group facilities are lacking.

The Buena Park Hotel offers over 350 tastefully appointed guest rooms with over 23,000 square feet of meeting/banquet space. There is a swimming pool and Jacuzzi facilities. In addition to two restaurants on the property, the location is central to a wide assortment of area restaurants. Hotel parking is free. The hotel has blocked 50 rooms and a Hospitality Suite for our group from 1 through 4 July. Reservations must be made on an individual basis directly with the hotel NLT 1 June, 1998 and all associated guest charges are to be paid by the individual. When making your reservations [(800) 422-4444 0r (714) 995-1111], do inform the reservation agent that you are with 'The 4th PSYOP Group Mindbenders Reunion' in order to receive the special rates. Check with the reservation agent to insure that you understand the hotel's cancellation policy. (Although 1 June, 1998 is the cutoff date for our room block and special rates, I CANNOT EMPHASIZE ENOUGH THE NEED TO BOOK EARLY. Knotts Berry Farm is a very popular attraction and I anticipate the hotel asking us to reduce the number of rooms to accommodate the summer surge. We have already lost one opportunity to another group with specific reservations to back their intent.)

For those intending to fly into the area (Orange County [aka John Wayne], Los Angeles, Ontario airports or San Diego), a rental car is recommended as there are numerous activities available in the greater Los Angeles, Orange County and San Diego areas. However, there is bus and shuttle service from both Orange County and LAX airports. The 'Airport Bus' leaves quite frequently and stops at the hotel (a transfer at Disneyland will be necessary from Orange County Airport). Remember, that when making flight plans, that there is a three hour difference in Pacific and Eastern time. You can arrive early enough to enjoy some sightseeing before it gets dark. I've included two maps of the area indicating the location of the Buena Park Hotel.

Travel Arrangements:

Travel arrangements are the responsibility of individuals concerned. However, airfare discount arrangements have been made with Northwest Airlines as the Preferred Airlines for the 'Mindbenders' Reunion. These fares are discounted off the current lowest published round trip fares into Orange County, Ontario, Los Angeles and San Diego airports. (Not valid with other discounted fares such as senior and under \$100 fares.) Tickets must be purchased through Mr. Gordon Eisert at 'All Points Travel' in Louisville, KY. Phone (800) 627-6468. Please mention '4th PSYOP Group Mindbenders' reunion to get these special fares. For those traveling by air, regardless of the airlines, it is recommended that tickets be purchased as early as possible for lower fares.

Special Events:

We are very fortunate in that one of our West Coast members, has memberships in two exclusive local Southern California attractions and has generously offered to sponsor our participation in both activities for interested members:

THE MAGIC CASTLE: The Hollywood clubhouse of the Academy of Magical Arts, Inc., a non-profit organization devoted to the advancement of the art of magic. For those interested, The Magic Castle offers a variety of 20 and 45 minute magic shows in an old Hollywood mansion. Admission is \$10.00 with the dinner meal priced (moderately high) separately. Those we know who have been to the Magic Castle have thoroughly enjoyed themselves. We have learned that, unfortunately, there is a minimum age of 18 to attend.

CLUB 33 inside Disneyland Park: CLUB 33 is Disneyland's secret club - so secret that many Disneyland employees don't know it's there, at 33 Rue Royale in New Orleans square, near the Pirates of the Caribbean. To be granted admission, you must be a member or a guest of a member. The club can't be found on any maps of the park. Disneyland shrouds CLUB 33 with a veil of secrecy and discourages publicity of club details. CLUB 33 offers fine dining to a select list of members. Only those chosen few and their guests are admitted, and the only way to become one of the approximately 400 members is if one drops out. The waiting list is years long with membership as far away as England and Australia. Our host is arranging a CLUB 33 gourmet breakfast buffet for our group on Friday, 3 July. The price is currently \$37 per adult (12 and older) and \$33 for children (3 to 11) which includes park admission for the entire day. As Park admission alone is normally \$38 for adults and \$28 for children, we will essentially be getting the gourmet breakfast for free. This arrangement also gives us the opportunity to be first in line for the favorite rides when the Park opens on one of the busiest weekends of the year.

Reunion Registration:

Reunion registration and event fees are listed on the attached tear our/mail in registration form. Please fill out and mail along with your registration fee(s) payable to the '4th PSYOP Group Mindbenders Association' to the address shown on the form. The Disney Breakfast will be reserved for the first 76 applicants with paid fees. Disney Breakfast fees will be refunded after the reunion to those who were unfortunate enough not to be among the first 76 applicants. The fees include a non-refundable \$5.00 per family fee to help cover the business meeting and administrative expenses. Excess registration fees, if any, remaining after the reunion will be turned over to the Association.

Cancellation Policy:

We will attempt to accommodate reunion registration cancellations or changes prior to 1 June 1998 with fees refunded as appropriate. However, because of deadlines invoked by conditions beyond our control, banquet fees will not be refunded after 1 June 1998.

Telephonic Contacts:

This newsletter is being mailed to everyone on our master roster whether they are Association members or not. Between now and the end of March, a group of volunteers will be calling everyone on the roster who have not yet responded to our earlier questionnaires in order to answer questions and encourage their participation and comradeship.

Disneyland. A full day's event, especially for all the kids, including us older ones. A shuttle is available, but some of you may want to take cars in case you get tired and want to return to the hotel for a rest. Hand stamps are available at the exit gates for those wishing to return later in the evening. The price is currently \$37 per adult (12 and older) and \$33 for children (3 to 11) which includes a full day's use of all activities as well as a very special breakfast buffet in the little known but exclusive Club 33 in New Orleans Square in the park. You won't want to miss this opportunity as only one park visitor in perhaps 10,000 ever gets to visit this well kept Disney secret. We need to be at the gate by 7:00 am for breakfast.

For those wanting to visit Disneyland but not partake of the breakfast, the Park opens at 10:00 am. Admission is \$38 for adults (12 and over) and \$28 for ages 3 to 11. Children under 3 are free.




Early hotel reservations and reunion registration is strongly encouraged in order to insure room availability and help the reunion committee determine facility requirements. Your cooperation is appreciated.



Reunion in the BIG APPLE

Mid September is one of the most pleasant times to be in New York. Not only did the end of summer bring milder temperatures and a welcome break from humidity but it also brought our long awaited visitors from both California and Ohio.

Hazel and Frank Coburn from west of the Rockies and Gary, Linda, and Heather Conly from the Buckeye State, arrived the second week of September.

This was Frank and Hazel's first visit to New York and we tried to

squeeze in as many "touristy" things as possible. The Conly's had visited us on a previous occasion and, although we took in some of the same sights, I think they enjoyed themselves the second time around.

Al and I have often played tour guide to visiting friends and relatives and we always enjoy the experience. We never tire of seeing the magnificent views from atop the Twin Towers, the stately majesty of the Statue of Liberty, the echoing halls of Ellis Island. The splendor and serenity of St. Patrick's Cathedral is a sharp contrast to the hustle and bustle of Fifth Avenue, which lies just outside its massive doors.

We slowed the pace a bit at times and toured parts of Long Island as well. We drove to Cold Spring Harbor and conducted a self-guided tour of this historic whaling town. We amble through its museum and quaint shops. At Old Bethpage Restoration Village we stepped back in time to Colonial days. Original buildings of the 16th and 17th centuries are transported and restored at the Old Bethpage. Workers dress in traditional clothing and maintain the Village with the same kind of tools and crafts used in Colonial days.

As we approached the farming section, we saw in the distance, what looked like a penned up calf. As we grew closer, we were surprised to see that the calf was actually a pig. Gary commented that the pig had to have weighed close to 1000 pounds. Gary had been raised on a farm and knew such things. We considered him the resident expert. 



Dear Fellow Mindbenders,

It has been several months since we have last been in contact...there is much to share as we move closer to our 1998 Mindbenders' Reunion in Anaheim, CA. A few "first things first" items to share with you...

I regret to report that we have lost one of our brethren. Chris Christiansen, our former financial officer, has died of cancer. We lost Chris just after last Christmas, and he is so keenly missed. I first met Chris at our Ft. Bragg reunion, and have enjoyed his company ever since. He was completely committed to Mindbenders', and we to him. As friends of Chris and on behalf of

Mindbenders, Dick Holzheimer and Rick Hofmann attended services for Chris at Arlington National Cemetery in Arlington, VA. We are saddened by Chris' passing, but we are also better for having shared at least part of our lives with him.

We are in a bit of controversy with the Headquarters of 4th PSYOP Group at Ft. Bragg. After all these years, the Commanding Officer has decided that the name "Mindbenders" over the 4th Group crest violates Army Regulations regarding the presentation of Army symbology. There are some conflicting interests involved...the Army offers our Mindbenders' newsletter as reading material in the lobby of the 4thGroup Headquarters, and doesn't feel it can do so with the 4th Group crest improperly displayed

(i.e., they won't put our newsletter out if we don't change it!); the other side includes the fact that we aren't part of the Army, receive virtually no input, advice or support from the Army, never hear from them, have no members from 4th Group except from the Vietnam period, and designed our logo for our own use as a private organization. One member asked me to remind 4th Group that "they are what they are today because of what we did in Vietnam." Truer words were never spoken!!

However, during an unofficial and unscientific survey of the Mindbenders' Executive Board, conducted with absolutely no scientific precision whatsoever, I was able to determine that there is no interest in changing our logo or in providing any aid or comfort to the 4th Group (the margin of error in my survey is immeasurable). As you will see later in the newsletter, he has made superb arrangements for hotel accommodations which are rival the excellence we have come to expect in previous reunions. As I close this letter, I ask each of you to reflect on your commitments to Mindbenders. We make commitments to different things in our lives, including the groups with which we interact. There are a lot of fellow Mindbenders who don't yet know we exist...when we do find each other they are always surprised and pleased to know that we are in business. What are you doing to help us reach our growth goals? Have you made a call to that 'Nam vet you served with nearly 30 years ago? Have you made contact with anybody on the roster and asked if they'll join us in Anaheim in '98? Are you and a new member planning to join us in Vietnam in 2000? I'm not challenging your commitments, only asking that you "check in" with yourself to see if you can commit any energy to helping Mindbenders grow?

My first year in office has been fun....I've really enjoyed the interaction with so many fellow 'Nam vets. I'm looking forward to the next year, culminating in Anaheim with all of you.

MINDBENDERS 1998 REUNION "WEST COAST ADVENTURE" 1-5 JULY 1998

Well, arrangements are underway for our next reunion in sunny Southern California. As this is our first West Coast reunion, we're looking forward to seeing our West Coast members who have been unable to attend previous reunions in the East or Mid-West. This is also a golden opportunity for you Easterners to come out for the reunion and then continue your vacation and visit many of the lovely and unusual attractions for which California is noted. As was recommended, an additional day has been added to the schedule to provide more opportunity to visit local sights. We plan to start events on Wednesday, 1 July 1998

Although Linda and I live near Disneyland in Anaheim, California, our review of many of the hotels in the area led to the selection of the Buena Park Hotel and Convention Center in Buena Park, California for the reunion site. The Buena Park Hotel is located on Buena Park's Entertainment Corridor approximately five miles Northwest of Disneyland and just a short complimentary shuttle ride to/from Disneyland Park. The hotel is adjacent to Knotts Berry Farm amusement park and within walking distance of the Movieland Wax Museum, Wild Bill's Western Dinner Show, Medieval Times Dinner Show, and Ripley's Believe It Or Not. It is also only four blocks from the Buena Park Mall with its 160 stores and 8 cinemas. For what the hotel provides, we believe their special group rate (\$69 + tax per night) is more affordable than similar hotels near Disneyland which are around \$100 or more per night. Of course, cheaper accommodations may be available at smaller motels (this is the height of the tourist season), but the rooms are not as nice and group facilities are lacking.

The Buena Park Hotel offers over 350 tastefully appointed guest rooms with over 23,000 square feet of meeting/banquet space. There is a swimming pool and Jacuzzi facilities. In addition to two restaurants on the property, the location is central to a wide assortment of area restaurants. Hotel parking is free. The hotel has blocked 50 rooms (each room can accomodate up to 4 persons) and a Hospitality Suite for our group from 1 through 4 July. Reservations must be made on an individual basis directly with the hotel NLT 1 June, 1998 and all associated guest charges are to be paid by the individual. When making your reservations, do inform the reservation agent that you are with 'The 4th PSYOP Group Mindbenders Reunion' in order to receive the special rates. (Although 1 June, 1998 is the cutoff date for our room block and special rates, I recommend that you make reservations before 1998 as Knotts Berry Farm is a very popular attraction and I anticipate the hotel may ask us to reduce the number of rooms to accommodate the summer surge.)

For those intending to fly into the area (John Wayne or Los Angeles airports), a rental car is recommended as there are numerous activities available in the greater Los Angeles, Orange County and San Diego areas. However, there is bus and shuttle service from both airports. The 'Airport Bus' leaves quite frequently and stops at the hotel (a transfer at Disneyland will be necessary from John Wayne Airport). Remember, that when making flight plans, that there is a three hour difference in Pacific and Eastern time. You can arrive early enough to enjoy some sightseeing before it gets dark.

We are very fortunate in that one of our West Coast members, has memberships in two exclusive local Southern California attractions and has generously offered to sponsor our participation in both activities for interested members:

THE MAGIC CASTLE: The Hollywood clubhouse of the Academy of Magical Arts, Inc., a non-profit organization devoted to the advancement of the art of magic. For those interested, The Magic Castle offers a variety of 20 and 45 minute magic shows in an old Hollywood mansion. Admission is \$10.00 with the dinner meal priced (moderately high) separately. Those we know who have been to the Magic Castle have thoroughly enjoyed themselves.

CLUB 33 inside Disneyland Park: CLUB 33 is Disneyland's secret club - so secret that many Disneyland employees don't know it's there, at 33 Rue Royale in New Orleans square, near the Pirates of the Caribbean. To be granted admission, you must be a member or a guest of a member. The club can't be found on any maps of the park. Disneyland shrouds Club 33 with a veil of secrecy and discourages publicity of club details. Club 33 offers fine dining to a select list of members. Only those chosen few and their guests are admitted, and the only way to become one of the approximately 400 members is if one drops out. The waiting list is years long with membership as far away as England and Australia. Our host is arranging a Club 33 gourmet breakfast buffet for our group on Friday, 3 July. The price is currently \$36 per person (subject to change and is limited to 75 persons on a first come first serve basis) which includes park admission for the entire day. The price for children 12 and under will be less. As Park admission alone is normally \$36 per adult, we will essentially be getting the gourmet breakfast for free. We will also then have the opportunity to be first in line for the favorite rides when the Park opens on one of the busiest weekends of the year.







UPDATE MINDBENDERS 1998 REUNION "WEST COAST ADVENTURE" 1-5 JULY 1998

Planning for the 1998 Mindbenders' reunion is well underway. The Buena Park Hotel, which takes special pride in catering to military reunions, is now under contract for special guest room rates and meeting/banquet rooms. Negotiations for banquet fare and rates will soon be underway. Once 100 people have registered for the banquet, we can arrange for free use of the banquet hall on the eighth floor of the hotel. This is a very nice area with picture windows offering a panorama of adjacent areas. As the tallest building locally, the hotel provides a great view, especially after dark.

At present, we are arranging for a hospitality suite for rest and conversation with fellow attendees should you have the inclination. In addition, the Buena Park Visitors Bureau has agreed to provide reduced price coupons for a variety of local attractions within a two hour drive.

Based on the hard work of another of our members, Disneyland and Magic Castle planning is also coming along splendidly. We are now formally scheduled for the Club 33's gourmet breakfast buffet followed by a full day at Disneyland (both for the price of the breakfast) on 3 July. He is very enthusiastic about supporting a tour of the Company's printing and radio facilities on 2 July. He will also attempt to bring in additional field equipment from a sister Company. Arrangements, however, are still tentative as he has to obtain approval through his chain of command. A note of interest: his boss is now in Bosnia directing real world PSYOP efforts supporting the Peacekeeping mission.

The reunion description provided in the last newsletter has been updated and reprinted for information purposes in the hope that more Mindbenders will respond to the questionnaire and support our planning efforts. At the present time we only have responses indicating that 27 people are interested in attending. Although providing the information at this time does not commit anyone to the reunion, we will reserve the limited Disney Club '33' buffet spaces for those that notify us of their interest on a first come first saved basis.

As this newsletter is being sent to everyone on our roster rather than just to current members of Mindbenders, we sincerely hope that many of our former comrades who have been unable to attend past reunions will be able join us at our 1998 get together. Formal membership will not be a criteria for participation, just good fellowship. We also encourage everyone to call






